Member At Large

Bill Anelli, Modesto Jr. College

My involvement this past term as member-at-large included helping to organize the AAPT session, APA Pacific meeting (2012), "*The Craft of Structuring Writing Assignments*," chairing the AAPT session, APA Eastern (2011), and participating in the AAPT Teaching Fellows award selection committee. In addition I presented at the biennial AAPT conference in Austin and the APA/AAPT session in Seattle.

Presently I teach a range of philosophy courses including environmental ethics, political philosophy, and critical thinking, at Modesto Jr. College, a community college located in the central valley of California about 90 miles east of San Francisco. I am also advisor to our philosophy club and active on many campus committees including professional development where I work to effect cross-discipline pedagogy discussions on our campus.

As member at large I would also bring an important voice to the board – the perspective of those who teach at two-year community colleges, often with 5-5 loads.

Galen Foresman, North Carolina A&T State University

At the recent AAPT workshop/conference I was excited about the work, plans, and direction of the current board and members. I see the AAPT playing an important role in advocating for philosophy programs and teachers around the country, while simultaneously developing good practices and standards in our discipline through evidence based research. I have not been on the board in the past, but I did serve on the most recent Programs Committee and am currently serving on the Elections Committee. I have experience with institutional and program level assessment as a Teagle Assessment Scholar through the Center of Inquiry in Liberal Arts, and I was recently awarded a grant from the Council of Graduate Schools to work on assessing Ethics Education in Graduate International Collaborations. My faculty position is Assistant Professor of Philosophy at North Carolina A&T State University.

Mara Harrell, Carnegie Mellon University

I am an Associate Teaching Professor of Philosophy at Carnegie Mellon University. I have been a member of the AAPT for quite a number of years now. I gave a presentation at the first AAPT conference I attended in 2006 and most recently I attended the AAPT conference this summer in Austin. I am currently the Director of Undergraduate Studies in the Philosophy Department. Part of my job is to oversee the training of our graduate students to become teachers, and another part is to coordinate all of the sections of our introductory course, which I teach every semester. I have been at CMU for 9 years, and before that I taught at Colorado College for three years. My original research was in Philosophy of Physics, but as soon as I moved to CMU, my research focus switched to undergraduate education. I would love to be a member-at-large of the AAPT as I think it is one of the most important resources we have as teachers, and I want to help the organization grow and flourish as much as possible.

Tziporah Kasachkoff, Ben Gurion University of the Negev and City University of New York

I have spent most of my teaching career as a philosophy teacher at two ends of the educational spectrum: at a community college teaching incoming students, and at a graduate center teaching advanced courses—both at the City University of New York. Aside from my interest in ethics, social, and political philosophy, my major interest is in teaching itself, an interest reflected in my joint-editorship (since 1986) of the *American Philosophical Association Newsletter on Teaching Philosophy*. In addition to numerous articles, I have published three anthologies, two on the teaching of philosophy (and one on morality and public policy). In 2000 I received the AAPT's Award for Merit for *Outstanding Leadership and Achievement in the Teaching of Philosophy*. Being a participant and contributor to AAPT is a joy and an honor, and I view service to the organization as a Board member in that light.

Joyce Lazier, Indiana University—Purdue University Fort Wayne.
